 the just Sum of three thousand and thirty five pounds of Merchantable Tobacco
 to be paid upon demand and by reason thereof & also by force of the Statute in such
 Cases lately made and provided the sd. Hester became chargeable to pay to the sd.
 John the aforesaid Sum of Tobacco according to the tenor of the sd. Note and so being
 chargeable the aforesaid Hester afterwards to wit the aforesaid eighth day of June in
 the year Seventeen hundred thirty three aforesaid at Somersett County aforesaid within
 the Jurisdiction aforesaid in Consideration thereof upon himself did assume and to the sd. John then
 & there did faithfully promise that he the sd. Hester the aforesaid Sum of Tobacco to
 the sd. John according to the tenor of the sd. Note would well & faithfully pay & content
 Nevertheless the aforesaid Hester his promise & assumption aforesaid in forme aforesaid made
 nothing regarding but plotting & fraudulently intending the sd. John in that & to
 craftily & subtilly to deceive and defraud the aforesaid Sum of Tobacco to the sd. John
 according to the tenor of the sd. Note hath not paid or contented altho' the same to do
 the sd. Hester by the sd. John on the aforesaid eighth day of June in the year last aforesaid
 & often afterwards at the County of Somersett aforesaid he was thereunto requested but
 the same to him hitherto to pay hath refused and still doth refuse and doing where:
 upon the sd. John saith he is wounded & hath damages to the Value of Six thousand
 pounds of Tobacco and thereupon he brings Writs et. — *Blodges de Jure M. Doe*

A Copy of the foregoing Declaration was made and sent to be served on the Defendant
 with the writ in the plea aforesaid according to act of assembly in such Cases made & provided &

At which said third Tuesday of June to wit the nineteenth day of the same Month
 And: Done: One thousand Seven hundred and thirty five being the day of the Return of the
 said writ cometh the said John Burnale by his attorney aforesaid and the Sheriff of Somersett
