

of the action aforesaid by which the same Ralph Lamanteth against the same John thereof defended Wherefore the
 aforesaid Ralph Corbin his damages by occasion of the non performance of the promise and assumption -
 aforesaid against the aforesaid John Britt ought to recover but because it is not known to the Court here what
 damages the aforesaid Ralph hath sustained in that part by occasion of the premises therefore it is Comma-
 :ed the Sheriff of Somerset County that by the Oath of honest and Lawfull men of his County he
 Diligently Inquire what damages the aforesaid Ralph hath sustained as well by occasion of the Non perform-
 :ance of the promise and assumption aforesaid as for his Costs and Charges by him about his suit in that
 part apposed and that Inquisition which thereupon he should take to the Justices of his Lordships County
 Court of Somerset to be hold at dividing Creek in the same County the third Tuesday of June next from under his Seal
 and the Seal of the said County together with the writ therof to him directed &c. and the same day is given to the aforesaid Ralph here also
 all which said third Tuesday of June to wit the seventeenth day of the same month and Dow One thousand seven hundred
 and thirty five before the Justices of his Lordships County Court of Somerset now here hold at dividing Creek in the same
 County came the said Ralph Corbin by his attorney aforesaid and the Sheriff ~~returned~~ returned a certain Inquisition before him
 taken at dividing Creek in the County aforesaid on the thirteenth day of May one thousand seven hundred and thirty five -
 by which it appears that the aforesaid Ralph Corbin hath sustained damages by occasion of the non performance of
 the promise and assumption aforesaid further than his Costs and Charges by him about his suit in that part appo-
 sed to six pounds Current money of Maryland and for those Costs and Charges to one pound of tobacco -

Therefore it is Considered by the Court here that the aforesaid Ralph Corbin recover against the aforesaid John Britt
 his damages aforesaid as by the Inquisition aforesaid appears as also one thousand and Eight - - -

1006 pounds of tobacco for his Costs and Charges aforesaid to the aforesaid Ralph by the Court
 here of his aforesaid damages as judged which certain damages in the whole do amount to six pounds Current
 money of Maryland and one thousand and nine - - - - - pounds of tobacco and the aforesaid
 John Britt mergeth &c

 of Maryland was summoned to answer unto Joseph Ennalls of the same province
 and of Dorchester County of a plea that he renders unto him the sum of eighteen
 pounds four shillings Current money which to him he oweth and Unjustly
 detaineth &c.

And Whereupon the same Joseph by William Goldborough his attorney
 saith that whereas the aforesaid Michael the third day of April which was in the
 year of our Lord God Seventeen hundred and thirty five at Somerset County
 aforesaid by his certain writing obligatory had granted himself to be bound unto
