And the afd said Charles Hodgson by William Baskingham his attorney saith and defendeth the

Charles and that the same Charles doth detain the debt therein mentioned as if afd Samuel above against him both
declared whereupon the same Samuel praye Judge out for his debt and his costs and damages sustained by
- occasion of the detaining of that same debt to him to be adjudged &c.

Therefore it is considered by the Court here that the afd Samuel (now admd. of Shilmon Lloyd Esq. Recover
against the afd said Charles Hodgson his debt afd and his costs and damages sustained by occasion of the
detaining of the same debt to one hundred and Ninety Nine — — — — — pounds of Tobacco to
199 the same Samuel (now of his afd) by the Court here adjudged and the afd defend in Merry &c.
