And whereupon the said Robert by Geo: Douglas his attorney complains that the aforesaid Matthew Dorman on the twenty fifth day of June last: Dord: Seventeen hundred & thirty four at Somerset County afo: within the Juris of the Court with force & arms one hour of the price of ten pounds current moneys of Maryland of the Goods & chattles of the said Robert did take & the said hours against the will & Consent of the said Robert did ride & immoderately use and work by the space of thirty days that is from the said twenty fifth day of June in the year afo: to the twenty fifth day of July then next ensuing & other harms to him then & there did to the great damage of the said Robert & against the peace of the right honourable the Lord Proprietary his good rule & Government whereupon the said Robert say he is damnifyed twenty pounds current moneys of Maryland & thereof he brings suit

Whereupon the said Matthew Dorman by Francis Allen his attorney cometh and defendeth the force & Injury when &c: and pray leave thereof to be argued hereuntilt next Court and he hath it, and the same day is given to the afo: Robert here also &c:

At which said next Court to wit the eighteenth day of March And: Dord: One thousand seven hundred and thirty four came again as well the afo: Robert Down as the afo: Matthew Dorman by their attorneys afo: and whereupon the afo: Matthew Dorman pray further leave thereof to be argued hereuntilt next Court and he hath it, and the same day is given to the afo: Robert here also &c:

At which said next Court to wit the seventeenth day of June And: Dord: One thousand seven hundred and thirty five came again as well the afo: Robert Down as the afo: Matthew Dorman by their attorneys afo: and whereupon the said Matthew Dorman as before defendeth the force and Injury when &c: and saith that he of the promises aforesaid above upon him imposed is not guilty in manner & forme as the afo: Robert above agt him hath complained and of this he puts himself upon j: Courtage: and the j: Court.

Thereupon it is Commanded the Sheriff of Somerset County that Immediately he should cause to come here before the Justices of his Lordship County Court of Somerset now sitting at Dividing Creek in the County afo: twelve &c: by whom &c: who wither &c: to recognize &c: because as well &c: and afterwards Immediately came thereof the Jury &c: and the Jurors of that same Jury by Joseph McCarter Esq: Sheriff of the County afo: to this Impannelled being called came to wit Day Scott John Water Thomas Waller Angelle Atkinson Jonathan Sturgi George Banston James Brown Wm Mills Rich: Chamber James Hearn John Lane and Archibald White who to say the truth of the promises afo: being duly tested
