And whereupon the sd. John by Francis Allen his attorney complains that whereas y^e. sd. Benjamin in his life time to witt y^e. ninth day of March Anno Dni Seventeen hundred & thirty three at the County of Somersett aforesd. within the Jud of this Court had accounted together with him the sd. John of sundry Sums of Tobacco & money by the sd. John before y^e. time due owing & unpaid and upon that acc^t. the sd. Benjamin was found in answer to him the sd. John in four pounds nine shillings & four pence three farthings cur^t. & money of Maryland and One hundred & twenty seven pounds of Tobacco and being so thereof Indebted the sd. Benjamin in his life time to witt on the aforesd. ninth day of March in y^e. year aforesd. at y^e. County aforesd. in consideration thereof upon himself did assume and to the sd. John then & there did faithfully promise that he the sd. Benjamin the sd. four pounds nine shillings & four pence three farthings in Cash or pork at ten shillings per hundred & One hundred & twenty seven pounds of Tobacco to the sd. John by the twenty fifth day of December then next ensuing he would well and faithfully pay & content and whereas also the aforesd. Benjamin in his life time & afterwards to witt the twenty fifth day of June Anno Dni Seventeen hundred & thirty three at the County of Somersett aforesaid within the Jud of this Court was Indebted unto the sd. John in forty pounds of Tobacco for one Gall of Rum by the sd. John & to the sd. Benjamin in his life time at the special Instance & request of the sd. Benjamin before that time there sold & delivered and being so thereof Indebted the sd. Benjamin in his life time in consideration thereof the day & year last aforesd. at the County aforesd. upon himself did assume and to the sd. John then & there did faithfully promise that he the sd. Benjamin the sd. forty pounds of Tobacco to the sd. John when he should be thereunto requested well & faithfully he would pay & content and whereas also the aforesd. Benjamin in his life time to witt the twenty fifth day of June Anno Dni Seventeen hundred & thirty three at the County aforesaid within the Jud of this Court was indebted unto the sd. John in other four pounds nine shillings & four pence three farthings cur^t. money of Maryland to be paid in Cash or pork at ten shillings per hundred & one hundred & sixty seven pounds of Tobacco for sundry properly chargeable in acc^t. & by acc^t. thereof hereunto annexed and herein Court produced may appear and being so thereof Indebted the sd. Benjamin in his life time in consideration thereof the day & year aforesd. last mentioned at the place aforesd. upon himself did assume and to the sd. John then & there did faithfully promise that he the sd. Benjamin
