And the aforesaid John Athinson by Francis Allen his attorney declared against the
aforesaid Thomas Lambden in the plea aforesaid as followeth vid.

Somerset County A^t Thomas Lambden late of Somerset County Merchant as dicit Thomas Lambden of Summerset County in the province of Maryland Merchant was Sumonred to
answer unto John Athinson of a plea that he render unto him eighty pounds curr. Cash of
Maryland which to him he owes and unjustly detains &c.

And Whereupon the sd John by Francis Allen his attorney saith that whereas the sd Thomas
the twenty fifth day of August anno Domini Seventeen hundred and thirty three at the County
of Somerset aforesd within the Jurisdiction of this Court by his certain writing obligatory which
the sd John with the seal of the sd Thomas Signed hereinto Court brings the date whereof
is the same day & year did acknowledge himself to be bound unto the sd John in the aforesd
Eighty pounds to be paid unto the sd John when he should be thereunto required yoll the
sd Thomas tho: often required the said Eighty pounds to the sd John hath not rendered but
the same to him hitherto to render hath done & still doth done and unjustly detain
to the damage of the sd John of ten pounds curr. money aforesd and thereupon he
brings vid. b.

A copy of the foregoing declaration was made and sent to be served on the defendant with
the writ in the plea aforesd according to act of assembly in such case made and provided &c.

At which said third Tuesday of June to wit the seventeenth day of the same month anno
Domini One thousand Seven hundred and thirty five being the day of the return of the said writ
cometh the said John Athinson by his attorney aforesd and the Sheriff of Somerset County to whom
the foregoing writ was directed likewise cometh and maketh return thereof to the Court here
indicated in these words following vid. Copy of your declaration delivered in time per Mr. Carter Sheriff
Whereupon came hereinto Court the said Thomas Lambden in his proper person and
thereupon at the prayer of the aforesd John Athinson by his attorney aforesaid the said Thomas
Lambden is adjudged to give special bail to the action aforesd Thereupon certain Charles Ramsey
and John Lamberson of Somerset County planter present herein Court in their proper person
undertook and each of them undertook for the said Thomas Lambden and affirmed upon
themselves (likewise the said Thomas Lambden present herein Court aforesd) affirmed upon
himself that if in case the said Mr. Athinson should recover judgment in the plea aforesd
against the said Thomas Lambden or that the said Thomas Lambden should be therein
Convicted that then he the said Thomas Lambden should pay the Condemnation of the
Court
