


August Court - - - 1735 - - - (61)

William Lane, Thomas Williams, Henry Ballard, David Wilson, Edward Rownd, Charles Ratcliff, George Dashiel, Thomas Gillis, Isaac Handy, and, Mitchell Dashiel and none others to be Judges also by these presents we do command the Sheriff of our said County of Somerset that at the severall Courts to be held for our said County he gives his attendance & cause to come before you or any three or more of you as such, & so many good and lawfull men of his bailey without out of racing every hundred thereof by whom the truth of their matter in the premises may be the better known, Enquired of Lastly your cause to be brought before you at your said Courts also writs precepts, process, & Indictments to your Courts of Jurisdiction belonging that the same may be Inspected & by due course of Law determined witness our trusty & well beloved Samuel Ogle Esq; Lieutenant General & Chief Governor of our said Province of Maryland this sixteenth day of July in the 21st year of our Dominion & Annoq: Dom^t 1735
