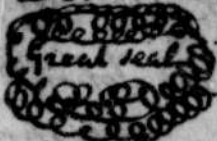

Lieutenant General & Chief Governour of our said provinces of Maryland this Fifteenth day of July in the 21. Year of our Dominion & Annoq. Dom. 1735
