in his proper person and whereupon the said Donnoch prayeth further leave thereof to Imparte hereuntill
next Court and he hath it and the same day is given to the aforesaid Joseph heral^r & g^t

All which said next Court to wit the nineteenth day of August and Dom^d One thousand Seven hundred
and thirty five came again the said Joseph M^r Parker by his attorney as and prayeth that the aforesaid
Donnoch Dennis to his declaration aforesaid may answer but the same Donnoch says nothing in bar or preclusion
of the action and of the aforesaid Joseph by which the same Joseph removeth against the aforesaid Donnoch -
herof undefended & g^t

Therefore it is considered by the Court here that the aforesaid Joseph M^r Parker
beover against the aforesaid Donnoch Dennis his debt aforesaid and his damages sustained by occasion
361 of the defrauding of the same debt to Three hundred and Sixty One - pounds of
tobacco to the same Joseph by the Court here of his aforesaid adjudged and to be defend^d in meny &

And whereupon the s^d Joseph by Francis All^r his attorney saith that whereas
the s^d Stanton the Ninth day of November Anno Dom^d Seventeen hundred &
thirty four at Somerset County before within this Part of this Court by his
certificate willing obligatorily w^t the s^d Joseph with y^r 1200 of y^r s^d Stanton
signed hereinto Court brings the date whereof is the same day & year did acknow-
ledged himself to be bound unto the s^d Joseph in the aforesaid eight thousand pounds
of tobacco to be paid unto the s^d Joseph when he should be the amount required
¶ At the s^d Stanton this? after required the s^d Eight thousand pounds of tobacco to
the s^d Joseph hath not rendered but the same to him hitherto to render hath denied
and still doth deny and unjustly detain to the damage of the s^d Joseph of four
thousand pounds of tobacco and thereupon he brings Suit & g^t
