To the worshipful Justices of Somerset County now in Court sitting  
The humble petition of John Phillips John Denston & Isaac  
Coster humbly sheweth - That whereas Robert Harris of this County  
last August Court obtained an order for a load from his now dwelling  
house in Sparrahawkin to a certain plantation of his called Deep Branch  
which said road is very prejudicial to your petitioners & y<sup>e</sup> main County  
road that leads from y<sup>e</sup> said Harris dwelling house to y<sup>e</sup> said plantation  
called Deep Branch is not above three quarters of a mile out of y<sup>e</sup> said  
Harris way your petitioners therefore humbly pray that your Worships  
will please to grant an order to such person as you shall think fit  
to view y<sup>e</sup> said road whereby your worships may be certified of the  
prejudice y<sup>e</sup> said road will be to your petitioners and they as in duty

The petition aforesaid being read and heard and fully understood and mature deliberation thereupon had.  
Wherefore it is considered and ordered that Thomas Dixon & John Williams of Somerset County have go<sup>ne</sup> <sup>and</sup> view  
and inspect the road or path that the said Robert Harris had obtained an order for <sup>last</sup> Court and that  
they the said Thomas Dixon and John Williams make their report immediately to this Court now here sitting at  
Dorchester and afterwards in the same Court came the said Thomas Dixon and John Williams the two Justices appointed  
to inspect the road or path aforesaid and upon making their report to the Court here the same Court did  
order that the said Robert Harris take no benefit of the aforesaid road or path that he had obtained an  
order for last Court, But that Randale Smullin and Joseph Ward both of Parsham North Devon  
cut and direct a bridle path for the said Robert Harris from his dwelling plantation in Sparrahawkin  
near to his upper plantation at the end of the said Parsham North Devon, the said path to be laid out  
and directed by the said Randale Smullin and Joseph Ward the most convenient for the said Robert  
Harris; but of the least of prejudice to any person or persons whatsoever and the said path so be  
laid out and directed as aforesaid to be kept and repaired at the expense of the said Robert Harris &c.
