other purposes, passed at December session 1836, chapter 220. As this bill proposes to appropriate money in the treasury, we are compelled to reject it; at the same time we have considered the objects which you proposed to accomplish by its passage, and approving thereof, have originated and now send you a similar bill, which we hope will receive your concurrence.
