undertook for the said Wrixham Crapper and assumed upon himself (likewise the said Wrixham Crapper present herein Court in his proper person assumed upon himself) that if it should happen that Judgment in the plea aforesaid should be rendered for the same Robert Bolton against him the same Wrixham or that the same Wrixham should be therein convicted that then he the same Wrixham should pay and satisfy unto the said Robert the Judgment of the Court thereupon or render his body in execution of such Judgment unto the prison of the sheriff of the County aforesaid there to remain until the same Judgment be fully satisfied or that he the said Thomas Conitor will do the same for him &c. and the aforesaid Wrixham Crapper puts in his place George Douglas attorney at Law against the aforesaid Robert Bolton of the aforesaid plea --- Whereupon at the prayer of the parties aforesaid Day is given to the parties aforesaid in the plea aforesaid here before his Lordships Justices at dividing Creek until the third Tuesday of March then next following in the same state wherein they now are coming to the parties aforesaid

And hereupon the said Robert Bolton declared against the aforesaid Wrixham Crapper in the plea aforesaid in form following vizt. - Somerseth County P. Wrixham Crapper late of Somerset County planter was summoned to answer unto Robert Bolton of a plea that he render unto him three pounds one shilling and three pence current money of Maryland and two hundred and forty pounds of Tobacco which to him he oweth and unjustly Detaineth &c. And Whereupon the said Robert by Francis Allen his attorney saith that whereas the aforesaid Robert at a County Court of the Right Honourable the Lord proprietary of this province held at dividing Creek in the County of Somerset in and for the said County of Somerset the third Tuesday in March Anno Dom. Seventeen hundred and thirty four before the worshipfull John Smith and his associates Justices of the same Court by the consideration of the same Court Recovered against the aforesaid Wrixham as well three pounds one shilling and three pence current money of Maryland for his damages which he sustained by occasion of a certain promise and assumption by the aforesaid Wrixham to the same Robert at Somerset County within the Jurisdiction of the same Court made & not performed as two hundred and forty pounds of Tobacco which to the same <sup>Robt. in the same</sup> Court then and there were adjudged for his costs and charges by him about his suit in that part apposed whereof the said Wrixham is convicted as by the Records and proceedings thereof in the County Court aforesaid of the Right Honourable the Lord proprietary here to wit at dividing Creek aforesaid in Somerset County aforesaid before the Justices aforesaid remaining more plainly it Manifest and appears which said Judgment is in full force strength & effect altogether unreversed or satisfied and the aforesaid Robert hath not yett followed any execution of the said Judgment by which Action accrued to the said Robert to have and require of
