And afterwards in the same Court before the Justices there of Lane John Dennis Junr. Late of Somerset County Inhabitant in his proper person and understood for the same William Lewis and affirmed upon himself [Likewise the same W. Lewis present here in Court in his proper person affirmed upon himself] that if it should happen that Judgment in the plea aforesaid in the same Court should be rendered for the same Daniel Carole against him the said William Lewis or that he the said William Lewis should be therein convicted, that then he the said William Lewis should pay and satisfy unto the said Daniel Carole the Judgment of the Court Whosoever or tender his body in Execution of such Judgment to the Prison of the Sheriff of the County aforesaid to remain until the same Judgment be satisfied unto the same Daniel Carole or that he the said John Dennis Junr. will do the same for him.

Thereupon the said William Lewis in his proper person Cometh & defendeth the force of Injury whereunto and upon this day is given to the parties aforesaid here until the third Tuesday of June then next following &c. At which day here came again as well the said Daniel Carole by his attorney aforesaid as the said William Lewis in his proper person, and thereupon the said John Dennis Junr. bail of the said William Lewis being present here in Court before the Justices there of deliver upon unto the same Court the Body of the same William Lewis in discharge of his Recognizance of Bail aforesaid, Entered into as aforesaid for the said William -

Thereupon at the prayer of the said Daniel Carole by his attorney aforesaid, the said William Lewis is adjudged by the Justices aforesaid here, to give other bail to the action aforesaid, unto the same Daniel Carole but for want thereof the same William Lewis is committed by the same Justices here into the Custody of the Sheriff of the County aforesaid to remain &c. until &c. the same Sheriff to wit Joseph W. Porter hath present here in Court by Francis Porter his deputy took charge of the same William Lewis accordingly, and thereupon further day is given to the parties aforesaid here until the third Tuesday of August then next following &c.

At which day here before the the Justices of his Lordships County Court of Somerset at Dividing Creek came again as well the said Daniel Carole by his attorney aforesaid as the said William Lewis ^{at the Sheriff's} in custody as aforesaid in his proper person and thereupon further day is given to the parties aforesaid until the third Tuesday of November then next following &c.

All which day before the Justices of his Lordships County Court of Somerset at Dividing Creek came here again as well the said Daniel Carole by his attorney aforesaid as the said W. Lewis in his proper person in custody of the Sheriff aforesaid, and thereupon the said Daniel Carole declared against the said William Lewis in custody as aforesaid upon the writ aforesaid vizt. Somerset County's William Lewis late of Somerset County planter otherwise called William Lewis now of Somerset County planter was summoned to answer unto Daniel Carole of a plea that he render unto him forty two pounds Curr. money of Maryland which to him he oweth and unjustly detaineth &c. And whereupon the same Daniel by William Beechingham his attorney saith that whereas the aforesaid William Lewis the ninth day of October Anno Domini seventeen hundred thirty and one at
