Whereas Doctor Patrick Stewart had due unto from Somerset County in the Year 1737 for medicines and attendance to Sundry poor Objects the Sum of thirty one pounds Eleven Shillings and Six pence Curr. money of Maryland ^{in Payment} which same amount should be allowed to the said Patrick Stewart in the Laying of the County Levy last &c but was omitted -

It is thereupon ordered that Cap^t John Henry sh^d. pay unto the said Pat^r Stewart Six pounds Nine Shillings & three pence Curr^t Money there being so much Lodged in his Hands at the Laying of the said Levy. Likewise it is ordered that Cap^t John Henry make up to the said Pat^r Stewart the said Sum of Six pounds Nine Shillings and three pence (paid by the said John Henry) thirty one pounds Eleven Shillings & Six pence Curr^t Money out of the fines due for forfeitures due to Somerset County if he hath so much thereof in his hands &c.
