Ordered that Thomas Caldwell recover against John Mitchell one hundred and fifty pounds of tobacco being due unto him for his attendance five days as an evidence on behalfe of his Lordship against the said John Mitchell having made oath to the same.

Came herunto Court and made it appear to the satisfaction of the same Court that she had fully paid abov<sup>e</sup> all the estate of the same Mary Save Smith part as doth belong to herselfe. Therefore the said abov<sup>e</sup> is discharged from giving any security.

Mary Smith Executrix of John Smith dec<sup>d</sup> being summoned to appear at this Court to give security for the balance of the said dec<sup>d</sup> estate. Came unto Court here aforesaid John Hornwell who had intermarried with the said Mary Smith the 2<sup>d</sup> of Febr<sup>y</sup> and did make it appear to the satisfaction of the Court that he had paid away the estate of the said John Smith dec<sup>d</sup> to the Representatives of the same John. Therefore they are discharged from giving any security for the same balance.
