John Jordine } John Jordine (son of Aaron Jordine late of Somerset County dead) an Orphan of his own bound to Henry Ballard. } free Consent is bound out by the Court here an apprentice according to act of assembly in such Case provided unto Henry Ballard of the same County Gent until he arrives at the age of Twenty One Years he being ten Years of age Last March the said John Jordine to serve his said Master the full term aforesaid during which term the said John Jordine his said Master well and faithfully shall serve his secrets keep his Commandments Lawfully and honestly every where willingly he shall do and in all things as a good and faithful apprentice he shall demean himself towards his said Master and all his during the term aforesaid In consideration of which Service the said Henry Ballard present herein Com in his proper person Covenanteth with the Justice of the same Court in Court Judicially Sitting in manner and form following vizt that he the said Henry Ballard during the term aforesaid shall and will Learn his said apprentice either the trade of a Black Smith or Cordwainer and give him during the same term One whole Year & half Schooling, and ~~and~~ also and Calf at the Expiration of his servitude and anew Suit of Cloaths over and above his Common Wearing Cloaths and Likewise find and provide for his said apprentice meat drink washing Lodging and Cloathing meet for such an apprentice to have & wear during the term aforesaid -- Whereupon the said Henry Ballard is ordered to give Recognizance for the performing of the Covenant aforesaid Thereupon the said Henry Ballard present herein Com in his proper person acknowledged himself Indebted unto the said John Jordine in the Sum of thirty pounds Sterling good & Law full money of England of his body goods or Chattells Land or tenements to the Use of the said John Jordine his heirs or assigns ^{to be made & Levied} If it happen that the said Henry Ballard do not during the term aforesaid Learn his said apprentice the trade either of a Black Smith, or Cordwainer, and do not give him ^{one} whole Year & half Schooling, and do not at the Expiration of his servitude give him anew Suit of Cloaths over and above his Common Wearing Cloaths and also and Calf, and Likewise find and provide for his said apprentice meat drink washing Lodging and Cloathing meet for such an apprentice to have & wear during the term aforesaid &c
