in the Courthouse at Dividing Creek the third Tuesday of June and about one thousand &  
seven hundred and thirty seven to answer unto his said Lordship &c.

And afterwards to will the said third Tuesday of June and about one thousand seven  
hundred and thirty seven the same term before the Justices of His Lordship's Justices at Dividing  
Creek aforesaid came the aforesaid Sarah Thompson in her proper person and had clearing of the  
Judgment aforesaid and saith that she cannot deny but that she is guilty of the premises aforesaid  
in his Judgment specified in manner and form as by the Judgment aforesaid above against  
her supposed. and the premises aforesaid in the Judgment aforesaid Expressly acknowledgeth and makes  
oath that a certain James Lee is the Begot<sup>er</sup> of the Child she stands Indicted for and puts herself  
thereof in mercy of his Lordship -- Whereupon all and Singular the premises being seen and by  
the Court here fully understood. It is considered that the aforesaid Sarah Thompson pay unto his Lord-  
ship the Right Honourable the Lord Proprietary for her fine by the Court laid upon her imposed for and  
by reason of the premises aforesaid whereof in sum aforesaid she is Conveyed Thirty Shillings, Current Money of  
Maryland (to the use of the County aforesaid) and that the said Sarah Thompson be taken to Satisfie  
said Lordship of the fine aforesaid. Whereupon the said Sarah Thompson is ordered to give Security to  
save and keep Indemnified the Justices of Somerset County and their Successors from all Costs Charges  
and Burthenes that might accrue by means of the birth of the Child aforesaid

Whereupon the said Sarah Thompson with Patrick Daley and Isaac Wheeler both of Somerset County  
planter her securitye at present before the Court in their proper persons and acknowledged themselves Indebted  
unto his Lordship the Right Honourable the Lord Proprietary of the province of Maryland in the sum of  
Just sum of Thirty pounds Sterling good and Lawfull money of England of their bodys good or collect  
Lands or tenementes Dignly and severally to be made and levied to the use of the Justices of the County  
aforesaid and their Successors. If it happens that the said Sarah Thompson her heirs Executors or admi-  
nistrators or any of them do and shall not from time to time and at all times hereafter acquit and  
charge and save harmless as well the Justices of Somerset County aforesaid and their Successors for  
being as also the Inhabitants of the said County of and from all Costs Charges trouble and Incon-  
venience whatsoever for or by reason of the birth maintenance nourishing and bringing up of the  
said Child and of and for male other suits charges trouble and demands whatsoever touching  
or concerning of the same. Likewise the said Sarah Thompson is ordered to give Security for  
the payment of their severall Officers their fees as due by means of the Judgment aforesaid  
Whereupon the said Sarah Thompson with the aforesaid Patrick Daley and Isaac Wheeler affores-
