

Justices in their proper persons undertook and each of them undertook for the same John Bishop and appointed upon themselves (likewise the same John Bishop present herassi Court in his proper persons - appointed upon himself) that if it should happen that Judgment in the plea aff in the same Court should be rendered for the same John Atkinson against him the said John Bishop, or that he the said John Bishop should be there: in Conscience that then he the said John Bishop should pay Bond Satisfie unto the said John Atkinson the Judgment of the Court thereupon or tender his body in Execution of such Judgment. to the prison of the Sheriff of the County of Herefordshire until the same Judgment be fully Satisfied or that they the same John Selby and Dennis Hudson will do the same for him: —

And the aforesaid John Bishop by Robert Duckins Henry his attorney Cometh and defendeth the force and Injury when &c. and the aff John Atkinson prays that the same John Bishop to his declaration aff may answer Whereupon the same John Bishop hath day to him given by the Court here until Friday the next the fourth day of this term to answer unto the declaration aff of the aff John Atkinson in the plea aff. and the same John Bishop at the same day solemnly called to answer Cometh not nor the said attorney of the aff John Bishop, for the same John nothing there of vaith in bar or preclusion of action aff, of the aff John Atkinson by which the same John Atkinson Cometh with the wrong against him unda- fended &c.

Therefore it is considered that the aforesaid John Atkinson recover against the aff John Bishop his debt aff and his damages by reason of the Detention of the same debt to five hundred and sixteen pounds of lawful money to the same John Atkinson of his affant by the Court here adjudged and the aforesaid John Bishop in mercy &c.

Thomas Durnall
vs
Wm Wye &c

Command was given to the Sheriff of Somerset County that he should take William Wye late of Somerset County Clerk if he should be found in his bailwick and him should safekeep so that he might have his body before the Justices of his Lordships County Court of Somerset to be hold at Durding Creek in the same County the third Tuesday of June and that he should not fail &c. and hereupon the said Thomas Durnall by Geo. Douglas his attorney declared against the same William Wye in the plea aff in form following.

William Wye late of Somerset County Clerk was attached to answer unto Thomas Durnall of a plea of trespass upon the case &c. And whereupon the said Thomas by Geo. Douglas his attorney complains that whereas the said Wye after the first day of May Anno Domini seventeen hundred and five to witt on the twentieth day of June Anno Domini seventeen hundred thirty and four at Somerset County aff did make his certain note in writing called a promissary note with his proper hand subscribed bearing date the day and year last mentioned and the said note to the said Thomas Durnall then and there did deliver by which note the said Wye did promise to pay to the said Thomas
