 in manner and form as the said Samuel above against him hath complained of and of this he puts  
 himself upon the Country &c — And the <sup>af</sup> Abraham prayeth that the <sup>af</sup> Samuel  
 may reply to the plea of the same Abraham and afterward the same Samuel altho' sole  
 :mely called cometh not to the plea of the same <sup>af</sup> Abraham replyeth nor is his writt <sup>af</sup> against  
 the said <sup>af</sup> further prosecuted — Therefore it is considered that the <sup>af</sup> Samuel  
 Beekley take nothing by his writt <sup>af</sup> but that he and his pledges of prosecuting  
 to wit John Doe and Richard Roe be in mercy and that the <sup>af</sup> Abraham as goe  
 thereof without day &c and further it is considered that the <sup>af</sup> Abraham recover  
 against the <sup>af</sup> Samuel Beekley: Two hundred & sixteen  
 256 — — — : pounds of tobacco for his costs and charges by him about his defence  
 of in that part sustained to the same Abraham Ingram by the Court here according  
 the form of the Statute in such case lately made and provided as judged and that the same  
 Abraham have thereof Execution &c
