

Ordered by the Court here that Cap<sup>t</sup> Edward Rownd be allowed and have an order on the Sheriff of Somerset County for three pounds Court-money of Maryland he producing herewith the third best piece of linen linnen according to act of assembly in such case made and provided -

Ed. Ezekiel Wise } Command was given to the Sheriff of Somerset County that he should take Adam  
Mrs. Adam Bradford } Bradford late of Somerset County Taylor if he should be found in his Bailiwick and he should  
safely keep so that he might have his body before the Justice of his Lordship's County Court of  
Somerset to behold or dividing Creek in the same County the third Tuesday of November and that he should  
Seven hundred and thirty six to answer unto Ezekiel Wise of plea of trespass upon the fact and that these of  
he should not fail - At which day here before the Justice of his Lordship's County Court of Somerset at  
Dividing Creek came the said Ezekiel Wise by George Douglas his attorney and the Sheriff of the same County  
to wit Joseph Mester here returned that he had taken the body of Adam Bradford whose  
body here at this day he had ready to answer unto the said Ezekiel of the said plea as to him it was command:  
ed for And the said Adam Bradford by William Gresham his attorney came hereto Court and thereupon  
at the request of the parties day is given unto them to be before the Justice of his Lordship's County Court of  
Somerset at dividing Creek the third Tuesday of November then next following in the state wherein they  
now are living to the parties of them

At which day here came again as well the said Ezekiel Wise as the said Adam Bradford by their attor:  
neys and here upon the same Ezekiel Wise declared against the same Adam Bradford in the plea of in  
form following - That Somerset County Adam Bradford late of Somerset County Taylor was attached to answer  
unto Ezekiel Wise of plea of trespass upon the fact

And whereupon the said Ezekiel by George Douglas his attorney complains that whereas  
the said Adam on the day of and date seventeen hundred thirty and at the County  
of was and still is a Taylor and whereas the said Adam in consideration that he the said Ezekiel  
then and there did assume to pay to the said Adam as much as he should reasonably deserve  
for making a coat and did then and there deliver to the said Adam as Coat and triming  
for the said Coat four yards and one half yard of Kersey of the value of twelve Shillings and  
Six pence Curr<sup>t</sup> of Maryland each yard and four yards of Shalloon of the value of three  
Shillings and Six pence of the money each yard and two dozen of Red buttons of the value of one  
Shilling and three pence of the money of the money each doz<sup>t</sup> and one dozen of small Buttons  
of the value of one Shilling of the money and one hand of Silk of the value of one Shilling and  
three pence of the money and two sticks of hair of the value of six pence of the money each stick  
and one yard of linnen of the value of one Shilling and Eight pence of the money upon him  
self
