 the said Robert to the said William at the special request and Instance of the said W^m
 before that time sold and delivered as by one other amount therof hereto annexed may appear
 and so being thereof indebted afterwards to wit on the day and year aforesaid at the County aforesaid
 upon himself did assume and to the said Robert then & there faithfully promise that he the
 said William the said Eleven hundred & seven pounds of tobacco when he should be afterwards
 thereto required well & faithfully pay or content. Nevertheless the said William his several
 promises and assumptions aforesaid in form aforesaid made nothing regarding but minding and fraud
 wilfully the said Robert in that part rashly and subtilly to deceive and defraud the said
 several Sums of money and tobacco or any part of them to the said Robert hath not
 paid or him for the same in any sort contented but the same to do hitherto altogether hath
 refused and still doth refuse altho' thereto afterwards to wit on the day and year aforesaid
 at the County aforesaid and often since that time by the said Robert required whereupon the
 Robert says he is damaged twenty pounds Curr^t money of Maryland & therof he brings
