Patrick Dalrymple } take Patrick Dalry if he should be found in his Bailiwick and him should  
safe keep so that he might have his Body before the Justices of his  
County Court of Somerset to be hold at Diving Creek in the same County the  
third Thursday of June then next to satisfy toward Karger of Two hundred and Sixty three  
pounds of Tobacco which to the same Court before the Justices thereof at  
Diving Creek by direction of the same Justices were adjudged for his Costs and Charges  
which he sustained on a certain Bill in Chancery by the said Patrick against the same Dow  
in the same Court and granted according to the form of the writ of Habeas Corpus made  
and provided against parties plaintiffs which their Bills in such manner do not prosecute or  
in the same should be precluded whereof he is convicted

All which day here came the said Edward Karger by Francis Otton his attorney and the  
Sheriff of the same County to wit Joseph M. Carter and at the same day here returned that he  
had taken the said Patrick Dalry whose Body here at this day he had ready to satisfy in as to him  
it was commanded
