The Same Somerset J. Memorandum that at a Session of the peace of his Lordship the Right Honble - William Bowen the Lord Proprietary of the province of Maryland held at dividing Creek in Somerset County the third Tuesday of March to wit the Seventeenth day of the same month Anno Domini one thousand seven hundred and forty before his said Lordships Justices the peace in the County aforesaid to keep assigned by the oath of twelve Jurors being presented that William Bowen late of Allhallowes parish in the said County of Somerset planter the sixth day of march in the year of our Lord God Seventeen hundred & forty with force and Arms &c at the parish aforesaid in the County aforesaid within the Jurisdiction of this Court in and upon a certain Jonathan Sturgis in the peace of God and the said Lord Proprietary that now is then and there being an assault did make and him the said Jonathan Sturgis and there did beat wound and evilly treat so that of his life it was greatly impaired and other harmes to the same Jonathan Sturgis did to the grievous damage of him the said Jonathan Sturgis and contrary to the peace of the right honorable the Lord Proprietary that now is his good rule & Government - Thereupon it is Comanded the Sheriff of the County of Somerset that he should take the said William Bowen

William Bowen if he should be found in his bailiwick and him should safe keep so that he might have his body before the Justices of his Lordships County Court of Somerset to be held at dividing Creek the third Tuesday of June one thousand seven hundred and forty one to answer - unto his said Lordship of the Indictment aforesaid

And now to wit at that same Court held for the County aforesaid the third Tuesday of June being the sixteenth day of the same month Anno Domini one thousand seven hundred and forty one before the aforesaid Justices at dividing Creek came the aforesaid William Bowen in his proper person and had a hearing of the Indictment aforesaid and saith that he cannot deny but that he is guilty of the premises aforesaid in the Indictment aforesaid specified above upon him imposed in manner and form as by the Indictment aforesaid against him supposed and the premises in the Indictment aforesaid Expressly acknowledged Whereupon all and singular the premises being seen and by the Court here fully understood

It is Considered by the Court here that the aforesaid William Bowen pay unto his Lordship the Right Honble the Lord Proprietary of the Province of Maryland for his fine by the Court here upon him imposed for and by Occasion of the premises aforesaid whereof in form aforesaid he is bound One Shilling Current money of Maryland and that the said William Bowen be taken to satisfy his said Lordship of the fine aforesaid

Whereupon the said William Bowen is ordered to give security for the payment of all fees or fees due on the Indictment aforesaid to any person or persons whatsoever - Thereupon a certain Solomon Dennis of Somerset County planter present herein Court undertook for the said William Bowen to pay all fees or fees due to any person or persons whatsoever on the Indictment aforesaid in case the said William Bowen doth not pay the same &c
