

In obedience to the above warrant was Issued the following Attachment against the goods and Chattles of the as<sup>d</sup> John Evans according to Act of Assembly in such case made and provided &c

Somerset for Charles Absolute Lord and proprietor of the provinces of Maryland and Anlon Lord Baron of Baltimore &c To the sheriffe of Somerset County greeting we Command you that you Attach any the goods Chattles rights or Credits of John Evans late of Somerset County planter if they shall be found in your bailiwick to the value of thirteen hundred pounds of tobacco and when you have the same so Attached or any part thereof the same in your custody safe keep so that you have the same before our Justices of our County Court of Somerset be held at dividing Creek the third tuesday of June next then and there to be condemned according to Act of Assembly to and for the use of a certain Nehemiah King of Somerset County Gent unless the said John Evans by himselfe or his Attorney shall appear and answer unto the said Nehemiah King in a plea of his oath upon the fact. According to Law and that good & lawfull men of your bailiwick you make known unto the person or persons in whose hands you make the same Attachment that he she or they be and appear before our Justices of our County Court to be held as afo<sup>r</sup> to shew cause if any he she or they have <sup>why</sup> the same Goods Chattles rights or Credits so Attached in his her or their hands ought not to be condemned and Execution thereof had and made according to Act of Assembly in such case made and provided if to him her or them it shall seem meet & how you shall Execute this writ that you make known unto our said Justices at the day and place afo<sup>r</sup> and have you then and there this writt Witness John Scott Gent. one of our Justices of our said Court the twenty third day of March Anno Domini one thousand seven hundred & forty

At which day here came the as<sup>d</sup> Nehemiah King in his proper person and the sheriffe to wit John Handy Gent. now here returned the as<sup>d</sup> writt thereof endorsed in these words following

By vertue of the within writt to me directed to the Justices within mentioned I hereby Certifie that I have attached as the goods and Chattles of the within named John Evans in the hands of Sarah Roe s<sup>r</sup> to the value of thirteen hundred pounds of tobacco and in the hands of Sarah Roe Jun<sup>r</sup> thirteen hundred pounds of tobacco and I further Certifie that I have made known unto the said Sarah Roe s<sup>r</sup> and Sarah Roe Jun<sup>r</sup> before John Windsor and George Irving good and lawfull men of my bailiwick that they be and appear at the day and place within Contained as by the within writt I am Comanded to shew cause &c  
so answers John Handy sherrif --

And the aforesaid Sarah Roe Jun<sup>r</sup> Garnishe of the aforesaid John Evans in her proper person appears and saith that she cannot deny but that she hath of the goods and Chattles of the aforesaid John Evans, in her hands to five hundred and six pounds of tobaco, and One hundred and sixteen pounds of umbroak flax and not more, and the said Sarah Roe Jun<sup>r</sup> say that she cannot deny but that the aforesaid five hundred and six pounds of tobo., and One hundred and sixteen pounds of umbroak flax, ought to be condemned in her hands, for the use of the said Nehemiah King, as the goods and Chattles of the aforesaid John Evans, which the said Nehemiah King doth not gainvey.

Where upon the Court here at the prayer of the aforesaid Nehemiah King valued the aforesaid One hundred and sixteen pounds of umbroak flax, so as aforesaid Confessed, by the aforesaid Sarah Roe Garnishee as aforesaid, to Ten pounds of tobaco and not more

Where upon the said Nehemiah King prays that upon givening Security according to act of Assembly in such case made and provided the aforesaid five hundred and six pounds of tobaco, and One hundred and sixteen pounds of umbroak flax, of the value of ten pounds of tobaco, so as aforesaid Confessed, by the aforesaid Sarah Roe Jun<sup>r</sup> Garnishee as aforesaid, may be condemned in the hands of the said Sarah Roe Jun<sup>r</sup>; as of the goods and Chattles
