

By the Sheriff of the County aforesaid and at the Request of the aforesaid William Kitchen and by the Command of the aforesaid Justice are newly put on, whose names to the panel within written are asited according to the form of Statute in such case made and provided, which said Jurors so newly put on to wit William Brown, Charles Darhitt and David Bolk being called Likewise Come, who to say the truth of the premises aforesaid together with the other Jurors aforesaid first Impannell'd and Sworn, being elected, Try'd and Sworn upon their Oath say that the sd George Bozman in his Life did assume upon himself in manner and form as the sd William Kitchen above against the aforesaid Mary hath complain'd and assted the damage of the same William by Occasion of the nonperformance of the promise and assumption aforesaid beyond his Costs and Charges by him about his Suit in this part Expended to five pounds Curr. money of Maryland and for those Costs and Charges to one pound of Tobacco.

Therefore it is Considered that the aforesaid William Kitchen Recover against the aforesaid Mary Bozman his damages aforesaid by the Jurors aforesaid in form aforesaid assted as also ⁹¹³ pounds of Tobacco for his Costs and Charges aforesaid to the same William by the Court here of his about adjudged which damages in the whole amount to five pounds Curr. money of Maryland and ⁹¹⁴ pounds of Tobacco of the goods and Chattel, which were of the aforesaid George Bozman at the time of his death in the hands of the aforesaid Mary Remaining to be admitted if so much goods and Chattel in her hands she hath and if so much, in her hands she hath not, than the Costs to be Levied of the proper goods and Chattel of the aforesaid Mary and the sd Mary in Maryland.

10 A Thomas Nevel ^{on} Geo. Russell. Command was given to the Sheriff of Somerset County that he should take George Russell late of Somerset County Merchant if he should be found in his Bailiwick and him should safe keep so that he might have his body before the Justices of his Lordships County Court of Somerset to be held at dividing Creek the Tuesday of August Anno Domini one thousand seven hundred and forty to answer unto Thomas Nevel of a plea of trespass upon the Case and the same day is given to the sd Thomas here.

At which day here came the sd Thomas Nevel by William Arbuckle his Attorney and the Sheriff to wit John Henry Gent now here returned that he had taken the sd George Russell whose body here at this day he had ready to answer the sd Thomas Nevel of the sd pleas to him it was Commanded.

Whereupon the said George Russell being present here in Court in his proper person at the prayer of the aforesaid Thomas Nevel is adjudged to give special bail to the action aforesaid, but for want thereof the said George Russell is committed, into the Custody of the Sheriff of the County of Somerset, thence to remain, the said Sheriff to wit John Handy Gent. present herein Court took charge of the said George Russell accordingly.

And thereupon at the Request of the parties aforesaid day is to them now here given until next Court to be held at dividing Creek in and for the County aforesaid, the third Tuesday of November then next following, in the same state as at present saving to the parties aforesaid &c.
