Command was given to the Sheriff of Somerset County that he should take John Evans late of Somerset County planter if he should be found in his bailiwick and him should safe keep so that he might have his body before the Justice of this Lordships County Court

of Somerset to be held at dividing Creek the third Tuesday of June Anno Dom one thousand seven hundred and forty one to answer unto Joseph Ennalls of a plea of trespass upon the Case &c and the same day is given to the ap Joseph here &c

At which day here came the ap Joseph Ennalls by his Attorney <sup>Francis Allen</sup> and the sheriff to witt John Handy Gent now here returned that he had taken the ap John Evans whose body here at this day he had ready to answer the ap Joseph Ennalls of the ap plea as to him it was Comanded

And hereupon the said Joseph Ennalls declared against the ap John Evans in the plea ap in form following Somerset County ss John Evans late of Somerset County planter was attached to answer unto Joseph Ennalls of a plea of trespass upon the Case &c

And Whereupon the said Joseph by Francis Allen his Attorney complains that whereas the said John after the first day of may Anno Dom seventeen hundred and five to witt on the third day of Nov<sup>r</sup> Anno Dom seventeen hundred and thirty eight at the County of Somerset ap within the Jur<sup>is</sup> of this Court made his certain note in writing called a promissory note with his proper hand subscribed bearing date the same day and year last mentioned and the said note to the said Joseph then and there delivered by which said note the said John did Acknowledge to have received of the said Joseph four pounds in bills of Credit Curr<sup>ent</sup> money which said money or the like sum or quantity of four pounds he promised to return or repay again to the said Joseph on the last day of April next ensuing the said third day of November and by reason thereof as also by force of the statute in that case lately made and provided the said John became Chargeable to pay to the said Joseph the said sum of money according to the tenor of the said note and so being Chargeable the said John in Consideration thereof
