At which day here came again the ap. William Richard by his Attorney ap. and the ap. Richard Knight altho' solemnly called came not nor his writ ap. against the ap. William Richard further prosecuted

Therefore he and his pledges of prosecuting are in mercy and let the said Richard Knight name pledges and that the ap. William Richard goe thereof without day also it is considered that the ap. William Richard recover against the ap. Richard Knight his damages ap. by Occasion of the premises to: 164 pounds of tobacco to the same William by discretion of the Justices here at his request for his Cuts and Charges in that part sustained according to the form of the statute in such Case lately made and provided by the Court here adjudged &c.

You Stephen Coston and Cornelius Dickerson do Confess Judgment to Robert Geddes for the sum of one hundred pound. Eight Shillings and Six pence which sum was recovered by the said Robert Geddes against Stephen Coston on the Eleventh day of may 1741 before me the Said sum of one pound Eight shillings and six pence to be Levied of your Body goods or Chattles lands or tenements for the use of the said Robert Geddes in Case the said Stephen Coston shall not pay and satisfie to the said Robert Geddes the sum of one pound Eight shillings and six pence so as ap. recovered against him with the additional Cols thereon on the tenth day of Novem ber Next. Taken before me this 24 day of July 1741 In: Scott

Ordered that William Lane of Somerset County Gent divide the Roads, that now under James Howton and John Melton Overseers, of the Roads on the South side of Powomoke River, and that the said Lane Linnitt, and Order each Overseer their part of the said Road and Labourers &c
