And whereupon the said John by Geo. Douglas his attny complains that whereas the said William on the Eleventh day of may Anno Domini MDCCLXI at the County ass. was Indebted to the said John in the sum of seven pounds nine shillings and six pence Curr. money of Maryland for sundry matters and things properly Chargeable in acct. as by an account thereof hereto annexed may appear and so being thereof Indebted on Consideration thereof afterwards to wit the day and year last ass. at the County ass. on himself <sup>assumed</sup> and to the said John then and there faithfully promise that he the said William the said seven pounds nine shillings and six pence Curr. money when he should be afterwards thereto requested he would faithfully pay and Content and altho. the said William hath paid to the said John one pound Eighteen shillings part of the said seven pounds nine shillings and six pence never theless as to five pounds Eleven shillings and six pence residue of the said seven pounds nine shillings and six pence the said William his promise and Assumption ass. in form ass. made not regarding but minding and fraudulently intending the said John in that part craftily and Subtly to deceive and defraud the said five pounds Eleven shillings and six pence to the said John hath not paid but that to doo altogether hath refused and still doth refuse altho. thereto afterwards to wit on the day and year last ass. at the County ass. and often since that time by the said John required whereupon he says he is the worse twelve pounds Curr. money of Maryland &c thereof he bring Suit &c
