Whereupon all and singular the premises being seen and by the Court here fully understood it is considered by the Court here that the *As*: Marjorum Mallard pay unto his said Lordship the Right Honourable Charles absolute Lord and Proprietary of the provinces of Maryland for her fines by the Court here upon her imposed for and by occasion of the premises *As*: whereof in form *As*: she is bound thirty shillings Curr: moneys of Maryland and that the said Marjorum Mallard be taken to satisfy his said Lordship of the fines *As*: *Yes*.

Whereupon the said Marjorum Mallard is ordered to give good security for the payment of all fees or fees due on the Indictment *As*: to any person or persons whatsoever - Thereupon a certain George Douglas of Somerset County Gentleman present herein Court undertook for the said Marjorum Mallard to pay all fees or fees due unto any person or persons whatsoever on the Indictment *As*: in case the said Marjorum Mallard doth not pay the same *Yes*.

Thereupon the said Marjorum Mallard is ordered to give security for her appearance at the next Court to be held at dividing Creek in and for the County *As*: the third Tuesday of November then next following to give evidence on behalf of his said Lordship against the *As*: Charles Gads to the grand Jury *Yes*.

Whereupon same hereinto Court the *As*: George Douglas in his proper person and undertaking for the said Marjorum Mallard and acknowledged himself indebted unto his said Lordship the Lord Proprietary of Maryland in twenty pounds Curr: moneys of said Province of his body goods or Chattels Lands or tenements to the use of his said Lordship his heirs and Successors to be made and levied if it happens that the said Marjorum Mallard do not make her personall appearance before his said Lordships Justice at the next Court to be held at dividing Creek the third Tuesday of November then next following and do not then and there give such evidence as she shall know on behalf of his said Lordship against the said Charles Gads and that she do depart the same Court without Leave *Yes*.
