Memorandum that at a Session of the peace

Rachel Barnett of his Lordship the Right Honourable the Lord Proprietary of the province
of Maryland held at dividing Creek in Somersel County the third Tuesday of June (to wit)
the sixteenth day of the same month Anno Domini one thousand seven hundred and forty one before
his Lordships Justices the peace in the County aforesaid to keep asigned by his oath of twelve
Juryors presented that Rachel Barnett late of All hallowe Parish in the County aforesaid the
thirtieth day of August in the year of Our Lord One thousand Seven hundred and forty at the parish aforesaid in the County
aforesaid and within the Jurisdiction of this Court did Commit fornication with a certain person to the Juror aforesaid unknown
and did permitt the same unknown person then and there to beget a bastard Child on the body of her the same Rachel
Barnett to the high displeasure of almighty God to the Evill Example of all others in such case offending contrary to the peace
of the said Lord Proprietary that now is his good rule and Government and against the form of the Act of Assembly in such Case lately made
and provided aforesaid

Thereupon it was commanded the Sheriff of the County aforesaid he should take the said Rachel Barnett if she should be
found in his baileywick and her should saftly keep so that he might have her body before the Justices of his Lordships County Court of
Somerset to be held at dividing Creek the third Tuesday of August one thousand seven hundred and forty one to answer unto his said Lordship
of the Indictment aforesaid

And now to wit at a Court held for the County aforesaid the third Tuesday of August being the Eighteenth day of the same month on
Anno Domini one thousand seven hundred and forty one before his said Lordships Justices at dividing Creek came the aforesaid Rachel Barnett
in her proper person and had a hearing of the Indictment aforesaid and saith that she cannot deny but that she is guilty of the premises aforesaid in
the Indictment aforesaid prescribed in manner and form as by the Indictment aforesaid above against her supposed and the premises in the Indict-
ment aforesaid Expressly Acknowledgeth and maketh Oath that a certain Gammage Evans is the begetter of the Child she stands indicted for
and is willing to pay her fine for the fact aforesaid

Whereupon all and Singular the premises being seen and by the Court here fully understood It is Considered by the Court
here that the aforesaid Rachel Barnett pay unto his said Lordship the Right Honourable Charles Absolute Lord and Proprietary of the province
of Maryland for her fine by the Court here imposed for and by occasion of the premises aforesaid whereof in forme aforesaid she is Convict thirty
shillings Currant money of Maryland and that the said Rachel Barnett be taken to satisfy his said Lordship of the fine aforesaid

Whereupon the said Rachel Barnett is Ordered to give good Security for the paymt. of all fees or fees due on the Indictment
aforesaid to any person or persons whatsoever Thereupon a certain Joseph Lewis of Somerset County planter present herein Court
undertook for the said Rachel Barnett to pay all fees or fees due to any person or persons whatsoever on the Indictment aforesaid in case the
said Rachel Barnett doth not pay the same

Thereupon the said Rachel Barnett is Ordered to give Security for her appearance at the next Court to be held at dividing
Creek the third Tuesday of November then next following to give Evidence on behalf of his said Lordship against the aforesaid Gammage
Evans
