the said Thomas Pingley in his proper person and had a hearing of the Information Aforesaid and saith ~
that he cannot deny but that he is guilty of the premises Aforesaid in the Information Aforesaid specified above ~
upon him imposed in manner and form as by the Information Aforesaid above against him supposed ~
and the premises in the Information Aforesaid expressly acknowledgeth

Whereupon all and singular the premises being seen and by the Court here fully understood ~
It is considered by the Court here that the Aforesaid Thomas Pingley pay unto his Lordship the right ~
Honourable the Lord Proprietary of Maryland for his fine by the Court here upon him imposed ~
for and by Occasion of the premises Aforesaid whereof in form Aforesaid he is convicted gives shillings curr. ~
money of Maryland and that the said Thomas Pingley be taken to satisfy his Lordship of the ~
fine Aforesaid Whereupon the said Thomas Pingley is ordered to give good ~
Security for the payment of all fees or fees due on the Information Aforesaid to any person or persons ~
whatever ~ Thereupon a certain Samuel Mills of Somerset County planter present herein ~
Court in his proper person undertook for the said Thomas Pingley for the payment of all fees or fees ~
due on the Information Aforesaid to any person or persons whatsoever in case the said Thomas ~
Pingley doth not pay the same £ 100

Whereupon the said Thomas Pingley is ordered to give security for his good behaviour ~
and appearance at November Court next ~ Thereupon the Aforesaid Thomas Pingley with the Aforesaid ~
Samuel Mills of Somerset County planter his security both present herein Court in their proper ~
persons acknowledged themselves indebted unto his Lordship the Right Honourable the Lord ~
Proprietary in twenty pounds current money each of their bodys goods or chattels lands or ~
tenements severally to be made and levied to the use of his said Lordship his heirs and successors ~
If it happen that the said Thomas Pingley doth not make his personal appearance at the next ~
Court to be held at dividing Creek the third Tuesday of November then next following to answer unto ~
