Likewise the same Heber Whittingham with the aforesaid Samuel Wilson and Henry Ballard his Securitys all present herein Court in their proper persons aforesaid Acknowledged themselves Indebted unto his said Lordship the Lord Proprietary in forty pounds currant money of Maryland of their bodys goods or Chattles Lands or tenements severally to be made and Levied to the use of his said Lordship his heirs and Successors if it happen that the said Heber Whittingham doe not keep good rules and orders and do suffer Idle loose and disorderly persons to tipple game or Commit disorders or other Irregularities in his ordinary or house of Entertainment during the time that he shall keep the same Contrary to the true Intent and meaning of the Act of Assembly in such case made and provided aforesaid.

Jonathan Sturges - Jonathan Sturges of Somerset County Inholder came hereinto Court in his proper person and prays that he may be permitted to keep an ordinary or house of Entertainment in the County aforesaid for the use and convenience of the Inhabitants travellers and strangers as to them respectively shall seem meet which is by the Court hereunto him granted he giving Security to comply with the Act of Assembly in such case made and provided aforesaid.
