And the aforesaid Thomas by George Douglas his attorney comes and defends the force and Injury when & the same attorney say that he is not Informed by the same Thomas his Client of any answer for the same Thomas to the aforesaid Rosalini in the plea aforesaid to be given and nothing els thereupon saith by which the same Rosalini Remaneth against the aforesaid Thomas Chase thereof undefended

Therefore it is considered that the aforesaid Rosalini recover against the aforesaid Thomas Chase his debt aforesaid and his damage by Evasion of the detention of the same debt to Three Hundred and Eighty Two pounds of Tobacco to the same Rosalini of his as<sup>t</sup> by the Court here adjudged and the aforesaid Thomas Chase in mercy &c
