The Condition of the above obligation is such that whereas the Commissary Gen<sup>l</sup> hath transmitted unto this Court the Account of the estate of James Weatherly dec<sup>d</sup> wherein it is found that there is bal<sup>l</sup> due to the abovesaid orphans the sum of Sixty pounds eight shillings and five pence Curr<sup>t</sup> money therefore if the abovesaid Moses Alexander Joseph Digger and Randall Smullen they or any of their heirs Ex<sup>r</sup> or Adm<sup>r</sup> shall and do well and truly pay unto the abovesaid orphans the sum of Sixty pounds eight shillings and five pence Curr<sup>t</sup> money according to Act of Assembly and the dec<sup>d</sup> will when they shall arrive at full age to receive the same &c Then the above obligation to be void and of none effect otherwise to remain in full force and vertue &c
