 Command was given to the sheriffe of Somerset County that he should take John Wilman if he should be found in his bailiwick and him should safe keep so that he might have his body before the Justices of his Lordships County Court of Somerset to be held at dividing Creek the third Tuesday of November Anno Dom one thousand seven hundred and forty one to satisfy Archibald Mc Neal late of Somerset County Buyer of three hundred and forty pounds of tobacco which to the same Archibald in his Lordships County Court of Somerset before the Justices thereof at dividing Creek by discretion of the same Justices were adjudged for his Costs and Charges which he sustained in a certain plea of trespass upon the case by the as^s. John Wilman against the same Archibald Mc Neal in the same Court Impetrate according to the form of the statute thereof made and provided against parties plaintiffs which their writts in such manner of pleas do not prosecute or in the same should be precluded whereof he is Convict &c. and the same day is given to the as^s. Archibald here &c.

At which day here came the as^s. Archibald Mc Neal in his proper person and the sheriffe shewitt / John Handy gent^l. at the same day now here returned that he had taken the as^s. John Wilman whose body here at this day he had ready to satisfy the said Archibald of the Costs as^s. as to him it was Comanded &c.

 Command was given to the sheriffe of Somerset County that he should take John Leatt late of Somerset County planter otherwise called John Leatt of Somerset County and province of Maryland if he should be found in his bailiwick and him should safe keep so that he might have his body before the Justices of his Lordships County Court of Somerset to be held at dividing Creek the third Tuesday of November Anno Dom one thousand seven hundred and forty one to satisfy John Henry late Sheriffe as well a certain debt of Eight thousand pounds of tobacco which the same John Henry in his Lordships County Court of Somerset before the Justices thereof at dividing Creek recovered against him as of three hundred and seventy one pounds of tobacco which to the same John Henry in the same Court were adjudged for his Damages which he had by Occasion of the Detention of that same debt whereof he is Convict &c. and the same day is given to the as^s. John Henry here &c.

At which day here came the as^s. John Henry by ^{his Attorney} Robert Jenkins, Henry and the sheriffe shewitt / John Handy gent^l. at the same day now here returned that he had taken the as^s. John Leatt whose body here at this day he had ready to satisfy the said John Henry of the debt and damages as^s. as to him it was Comanded &c. and the said John Leatt being by the sheriffe Led to the barr by vertue of the writt as^s. and being by the Court here asked whether he was not the same John Leatt the same person that the as^s. John Henry in the debt and damages as^s. above convicted or not saith that he is. Thereupon the same John Leatt is Committed to the prison of the as^s. Sheriffe thereto remain in safe custody until &c.
