Whereas there was an order of Court ^{made} formerly to James Martin Samuel Hopkins J^r
John Scarbrough and Adam Spence of Somerset County Gent: to lay out and order a Road
from Snow Hill town to Joseph Schofields at the Seaside &c. but forasmuch as the said
Gent: had done nothing thereby &c.

It is now Ordered that the a^{fo}. Samuel Hopkins, Peter Stewart
and William Selby of the County a^{fo}. Gent: or any two of them lay out and direct the
Clearing of a new Road from Snow Hill a^{fo}. into the seaside Road by Henry Oldfield
the said new Road to be Laid out the nearest way to the place a^{fo}. and of ^{the} least of prejudice
to Any person or persons whatsoever which said Road when Laid out by the persons
a^{fo}. the a^{fo}. Adam Spence is appointed Overseer thereof and Cause the said new Road
to be Roaded and Cartwayed according to Law & persons towards Clearing of the said

to the mill branch, then crossing the Line to Spence's side so with the said Line to the brow ^{of the Hill}
Branch a^{fo}: thence the direct and best way with the ^{said} Branch to the old road and over the branch
where
