Wherefore it is considered by the Court that a Commission Issue to the said Daniel Jones as by the petition is granted and that William Doughton Charles Dashiell, Caution Laws and John Leatherbury of Somerset County Gent be Commissioners and examine Evidence and Grant the same Commission according to act of Assembly in such case made and provided &c

Whereas Gabriel Connelly was by Warrant bearing

Dated the fifteenth day of February 1741 under the hand and Seal of the Honorable Patrick Henry Esq. One of the Right Honorable the Lord Proprietary Justice of the provincial Court was committed to the custody of the Sheriff of Somerset County to be by him in his Goal safe kept till he should give good security in the sum of two hundred pounds Current money of Maryland, for his personal appearance at the next provincial Court to answer such matters and things as on his Lordship's behalf then, and there should be alleged against him, and in the mean time to keep the peace, and good behaviour, and the said Gabriel afterwards before me the Subscriber recognized himself in two hundred pounds, and for each of Beavins and William Beavins in one hundred pounds Current money aforesaid, each conditioned for the said Gabriel's personal appearance and answering at the said Court, and keeping of the peace and being of the good behaviour, in the mean time. William Beavins and for each of Beavins appearing since that time not to be sufficient in case the said Recognizance's should become forfeited to pay the Sums of money in which they severally Recognized; and the said Gabriel having this day refused to give better Security. I therefore hereby commit into your Custody the said Gabriel Connelly whom body you are to keep safe in your Goal till he shall keep willingly give good security for his personal appearance at the said Provincial Court in the Sum of two hundred pounds Current money aforesaid to answer whatever ^{matters or} things he shall on the part of his Lordship be then and there charged with and to keep the peace and be of good behaviour, in the mean time, or be thence discharged by due Course of Law &c ---

Whereupon came hereto his Lordship's County Court of Somerset then held at dining Great before the Justices thereof in Court Judicially sitting, the said Gabriel Connelly in Custody of the Sheriff of the County aforesaid, in whose Custody before that time for the Cause aforesaid was committed, and being by the said Sheriff led to the bar, in his proper person, and whereupon by the Leave of the Court the said Gabriel Connelly offered in Security
