Whereupon the said Mary Means is ordered to give Security to save and keep Indemnified the Justices of the County of Somerset and their Successors from all troubles burthens and Charges that might Arise by means of the birth and maintainance and bringing up of the Child af^s

Thereupon the said Mary Means with Benjamin Mitchell of Somerset County planter present here in Court in wh^os proper person acknowledged themselves Indebted unto his Lordship the right Hon^{ble} the Lord Prop^{ty} of the province of Maryland in thirty pounds Curr^t money of their bodies goods or Chattles lands or tenements severally to be made and Levied to the use of the Inhabitants of the County of Somerset for the time being If it happen that the said Mary Means and Benj^t Mitchell their heirs Ex^{ors} and Adm^{rs} or any or either of them doe not from time to time and at all times hereafter acquit discharge and save harmless as well the Justices of Somerset County Court for the time being and also the Inhabitants of said County of and from all Costs Charges and burthens whatsoever for or by reason of the birth maintainance nourishing and bringing up of the af^s Child and of and from all other suits Charges troubles or demands whatsoever touching or concerning af^s the same af^s

Whereupon the said Mary Means is ordered to give good Security for the payment of all fees due on the Indictment af^s to any person or persons whatsoever. Thereupon the af^s Benj^t Mitchell of Somerset County planter present here in Court understood for the said Mary Means to pay all fee or fees due unto any person or persons whatsoever on the Indictment af^s in case the said Mary Means doth not pay the same af^s

spinster the thirtieth day of November in the year of our Lord one thousand seven hundred and forty
