Thereupon the said Solomon Cropper with Samuel Hopkins of Somerset County Gentlemen his Security both present here in Court in their proper persons acknowledged themselves Indebted unto his said Lordship the Lord Proprietary in thirty pounds current money of Maryland of their bodies goods and Chattels Lands and Tenements to the use of his said Lordship his heirs and Successors Severally to be made and Levied If it happen that the said Solomon Cropper and Samuel Hopkins their heirs Executors and Administrators, or any or either of them do not from time to time and at all times forever hereafter acquit discharge and Save harmless as well the Justice of Somerset County Court for the time being as also the Inhabitants of said County of and from all Costs Charges and burthens whatsoever for or by reason of the birth maintenance, nourishing, and bringing up of the Child aforesaid, and of and from all other suits Charges troubles and demands whatsoever touching or concerning of the same &c. — thereupon the said Solomon Cropper is discharged of and from the premises aforesaid he paying his Several fees due by means of the premises aforesaid
