Whereupon General and was given to the Sheriff of Somerset County that he should take the said Mary Bailey if she to answer her. And now to wit at that same Court held for dividing Creek for the County of the third Tuesday of March to wit the sixteenth day of the same month anno Domini One thousand seven hundred and forty one before the aforesaid Justices came the aforesaid Mary Bailey in her proper person according to a certain Recognizance in this part first acknowledged and had on hearing of the Information aforesaid and saith that she cannot deny but that she is guilty of the premises aforesaid in the Information aforesaid specified above upon her Imposed in manner and form as by the Information aforesaid above upon her Supposed and made oath that a certain Absalom Hobbs is the begetter of the child she stands informed against and is willing to pay her fine for the fault aforesaid.

Wherefore all and Singular the premises being seen and fully understood it is considered by the Court here that the aforesaid Mary Bailey pay unto his Lordship the Lord Proprietary for her fine by his Court here upon her Imposed for and by reason of the premises aforesaid whereof in form aforesaid she is bound Thirly Shillings curr. money of Maryland and that the said Mary be taken to satisfy his said Lordship of the fine aforesaid.

Whereupon the said Mary Bailey is Ordered to give security for the payment of all fee or fees due on the Information aforesaid to any person or persons whatsoever — Whereupon Absalom Hobbs of Somerset County planter present herein but in his proper person undertook for the said Mary Bailey to pay all fees or fees due to any person or persons whatsoever till pays the said Mary Bailey doth not pay the same fee

at the parish aforesaid in the County aforesaid within the jurisdiction of this Court did commit fornication with a certain Mary Bailey
