Thereupon command is to the Sheriff of this County as that he should take the said Absolum Robbs if &c to answer &c and now to wait at that same Court held for this County as at dividing Creek this Sixteenth Day of March anno Domini one thousand seven hundred and forty one before the aforesaid Justices come the aforesaid Absolum Robbs in his proper person according to a certain recognizance by him and his security in this part first acknowledged and had a hearing of the Information aforesaid with that he cannot deny but that he is guilty of the premises aforesaid in the Information aforesaid specified in manner and form as by the Information aforesaid upon him supposed and is willing to pay his fine for the fact aforesaid

Whereupon all and singular the premises being seen and by the Court here fully understood it is considered by the Court here that the aforesaid Absolum Robbs pay unto his Lordship the Lord Proprietary for his fine by the Court hereupon him imposed for and by Occasion of the premises aforesaid wherein as he is convicted thirty shillings current money of Maryland and that the said Absolum be taken to satisfy his said Lordship of the fine aforesaid

Whereupon the said Absolum Robbs is ordered to give security to save and keep indemnified the Justices of Somerset County and their successors from all troubles and charges that might accrue by means of the birth maintenance and bringing up of the child aforesaid

Thereupon the said Absolum Robbs with George Dashiel of Somerset County gent his security both present herein Court in their proper persons acknowledged themselves indebted unto his said Lordship the Lord Proprietary in thirtieth pounds current money of Maryland of their body goods or chattles lands or tenements to the use of his said Lordship his heirs and successors severally to be made and levied If it happen that the said Absolum Robbs and George Dashiel their heirs executors or any or either of them do not from time to time and at all times forever hereafter acquit discharge and save harmless as well the Justices of the County Court of Somerset for the time being as also the Inhabitants of said County of and from all costs charges and burthens whatsoever or by reason of the birth maintenance nourishing and bringing up of the child aforesaid and of and from all other suits charges troubles and demands whatsoever touching or concerning of the same &c Thereupon the said Absolum Robbs is discharged of and from the premises aforesaid paying the several fees due by means of the premises aforesaid
