Whereupon the said Samuel Barker present herein Court as sd acknowledged himself indebted unto his said Lordship the Lord Proprietary in ten pounds Curr. money of Maryland of his body goods or Chattels Lands or tenements to the Use of his said Lordship his heirs and assigns to be made and Levied If it happen that the said Samuel Barker do not make his personall appearance before the Justices of his Lordships County Court of Somerset to be held at dividing Creek the third Tuesday of June then next following and do not then and there give such Evidence as he shall know on behalf of his Lordship against the sd Donnock Dennis for an assault and do depart the same Court without Leave &c and afterwards the aforesaid Recognizance is by the Court here discharged &c

His Lordship . . } Whereas a certain John Samberson and Alexander Maddox of Somerset County planters being guilty of an affray in the publick view of the Court, the Justices in Court Judicially sitting and Alexander Maddox. } Whereupon the sheriffs of Somerset County is ordered to take the said John Samberson and the said Alexander Maddox into his custody and them safe Keep so that he might have their Bodies here immediately in Court to answer the premises aforesaid &c and afterwards in the same Court same the said John Samberson and Alexander Maddox in Custody of the Sheriffs of the County sd, into whose Custody before that time for the cause aforesaid were committed and being by the Sheriff aforesaid set to the Bar is thereupon Instantly demanded how they would thereof acquit themselves of the premises sd, sayeth that they and each of them are guilty of the premises sd and putt them upon the favour of the Court &c

Therefore it is Considered by the Court here that the sd John Samberson pay unto his Lordship the Right
