

At which day here before his Lordships Justices came the aforesaid Francis Allen in his proper person and the Sheriff of Somerset County to wit John Handy Gent at the same day returned that he by virtue of the writ aforesaid to him directed he had by Joshua Monitt and Nathaniel Hough good and Law full men of his County: with made known unto the aforesaid Edmund Hough that he be before the aforesaid Justices at the day and place aforesaid to show & as to him within it was Comanded. - And the aforesaid Edmund Hough so forewarned and at the same day solemnly called came by George Douglas his attorney and said that he cannot deny but that the aforesaid Francis his Exemption against the aforesaid Edmund ought to have of the aforesaid Seventy pounds fourteen Shillings Current money of Maryland and Two hundred and Thirty Six pounds of Tobacco &c. . .

Therefore it is considered that the aforesaid Francis Allen have his Exemption against the aforesaid Edmund Hough of the aforesaid Seventy pounds fourteen Shillings Current money of Maryland and Two hundred and Thirty Six pounds of Tobacco in form aforesaid Acknowledged according to the form of the Act: in that behalf made
