And Whereupon the aforesaid Benjamin Sharpe Garnisher as aforesaid in his proper person comes and saith that he cannot deny but that he has of the Rights and Credits of the aforesaid Henry Reynolds to the Value of five pounds Current money of Maryland nor can he pay but that the same ought to be Continued in his hands for the Use of the said Levin Gale as of the Rights and Credits of the said Henry Reynolds which the said Levin Gale doth not gainway.

Likewise the said Henry Reynolds altho' solemnly called came not nor shew'd Cause why & but made default.

Whereupon the aforesaid Levin Gale by his attorney aforesaid pray's that upon giving Security according to act of assembly in such case made and provided that the aforesaid five pounds Cur<sup>t</sup>. money of Maryland so as aforesaid by the aforesaid Benjamin Sharpe and the Several goods and Chattles so as aforesaid attached and valued to Twenty nine pounds three Shillings and Six pence Cur<sup>t</sup>. money of Maryland as of the goods and Chattles Rights and Credits of the aforesaid Henry Reynolds may be Continued towards Satisfying unto the said Levin Gale his damages and all Costs and Charges accruing by means of the attachment aforesaid.

Thereupon a certain Robert Jarchin Henry of Somerset County Court present here in Court in his proper person undertook for the aforesaid Levin Gale according to act of assembly in such case made and provided that in case the said Henry Reynolds do at any time within year and a day appear and make all or any part of the said Levin Gale Claim against him, appear to be satisfied or otherwise to have been made before the day ending of this attachment that then the said Levin Gale shall make restitution unto the said Henry Reynolds of all or such part as shall be so made appear to be undue as aforesaid or that he the said Robert Jarchin Henry will do the same for him.

Therefore it is considered by the Court here that the aforesaid Sum of five pounds Current money of Maryland part of the Sum so as aforesaid attached and acknowledged by the aforesaid Benjamin Sharpe be Continued in the hands of the aforesaid Benjamin Sharpe as of the Rights and Credits of the aforesaid Henry Reynolds towards Satisfying unto the aforesaid Levin Gale his damages and all Costs and Charges accruing by means of the attachment aforesaid and that the aforesaid Levin Gale have them of right against the aforesaid Benjamin Sharpe according to act of assembly.

Also it is considered by the Court here that the Several goods and Chattles so as aforesaid attached and valued to Twenty nine pounds three Shillings and Six pence Current money <sup>of Maryland</sup> be Continued as the proper goods and Chattles of the aforesaid Henry Reynolds to wards Satisfying unto the aforesaid Levin Gale his damages and all Costs and Charges accruing by means of the attachment aforesaid and that the aforesaid Levin Gale have them of right.
