At which day here came the aforesaid John Woolford by his Attorney &c and the Sheriff to wit John Standy Gent. now here returned that he had taken the aforesaid Sarah Staples whose body here at this day he had ready to answer the aforesaid John Woolford of the aforesaid plea as to him it was Comanded

And hereupon the aforesaid John Woolford complained against the aforesaid Sarah Staples in the plea aforesaid in form following - Somerset s/ Sarah Staples late of Somerset County spinster administratrix of all and singular the goods Chattles and Credits which were of James Staples late of Somerset County dec<sup>d</sup> who dyed in testate as is said to answer unto John Woolford of plea of trespass upon the Case &c

And Whereupon the same John by Robert Jenchins Henry his Attorney complains that whereas the aforesaid James in his lifetime the tenth day of may in the year of our Lord one thousand seven hundred and thirty eight was indebted unto the same John in the sum of seven pounds six shillings and three pence Curr<sup>t</sup> money of the province of Maryland for divers goods wares and merchandizes to the aforesaid James in his lifetime by the same John sold and delivered and so thereof indebted being the aforesaid James then and there faithfully promise to pay to the same John the aforesaid seven pounds <sup>viz</sup> shillings and three pence when thereof afterwards he should be required Nevertheless the aforesaid James in his life time his promise and assumption aforesaid little regarding but minding and fraudulently intending the same John in that part craftily and suttley to deceive and defraud the aforesaid seven pounds six shillings and three pence in his lifetime according to his promise and assumption aforesaid hath not paid but the aforesaid James in his life time and the said Sarah after the death of the same James to whom administration of all and singular the goods Chattles rights and Credits which were of the aforesaid James at the time of his death at Somerset County by Nehemiah King Gent.
