March Anno Domini one thousand seven hundred and forty one to satisfie William Lockwood of four pounds
Curr^t money of Maryland and three hundred and nine pounds of tobacco which to the same William Lockwood
in the same Court before the Justices thereof at Dividing Creek were adjudged for his Damages which he had by
Occasion of a certain promise and Assumption to the same William by the ap^t Benjamin made and not performed
whereof he is Convict and the same day is given to the ap^t William here^o

At which day here came the ap^t William Lockwood by Robert Serichinis Henry his Attorney and
the sheriffe of Somerset County to witt John Handy gent^r now here returned that he had taken the ap^t Benjamin
Warrington whose body hereat this day he had ready to satisfie the ap^t William Lockwood of his Damages ap^t as to
him it was Comanded &c And the said Benjamin being by the sheriffe Led to the bar is asked by the Court
here if he was the Very same Benjamin the same person where which the same William Lockwood in the Damages
ap^t above Convicted or not says that he is. Therefore the said Benjamin Warrington is Committed to the prison
of the sheriffe ap^t there to remain in safe Custody untill the same William Lockwood of the Damages ap^t should
be fully satisfied &c
