At which Day here came the afo^d William Lockwood by Robert Jenckins Henry his Attorney and
the Sheriff of Somerset County to wit John Handly gent: nowhere returned that he had taken the afo^d Benjamin
Warrington whose body heretofore this day he had ready to satisfy the afo^d William Lockwood of his Damages afo^d as to
him it was commanded by the said Benjamin being by the sheriff bind to the barre is awid by the Court
here if he was the very same Benjamin the same person wherof which the same William Lockwood in the Damages
afo^d above convicted or not saip that he is. Therefore the said Benjamin Warrington is committed to the prison
of the Sheriff afo^d thereto remain in safe custody untill the same William Lockwood of the Damages afo^d shal be
fully satisfied.
