bound to } bound out by the Court here an apprentice unto Owen Daugh of Somerset County Gent:
Owen Daugh. } wheelwright until he arrives at the age of Twenty One years the said apprentice to serve
his said master the full term aforesaid during which term the aforesaid apprentice his said Master will
and faithfully he shall serve ^{in such sort} his Commandments Lawfully and honestly every where willingly he shall doe and in
all things as good and faithfull apprentice shall demean himself towards his said master and all his during the term
aforesaid... In Consideration of which Service the said Owen Daugh present herein Court in his
proper person Covenanteth with the Justices of the same Court in Court Judicially sitting in manner and following
that is to say that he the said Owen Daugh shall and will during the term aforesaid Learn his said apprentice the
Trade of afaul wheelwright and to lead write and Cypher as far as the Rule of three Inclusive and at the
Expiration of his Servitude give him anew Suit of Cloathes Over and above his Common wearing Cloathes and
Likewise provide for his said apprentice meat drink washing Lodging and Cloathing sufficient for such an
apprentice to have and wear during the term aforesaid &c.

Whereupon the said Owen Daugh is Ordered to give Surety for to Comply with the Covenants afo
Therefore the said Owen Daugh with a certain John Goddard of Somerset County planter his Surety both present
herein Court in their proper persons acknowledged themselves to be Indebted unto the said David Daugh in
forty pounds Current money of Maryland of their bodies goods or Challee Lands or Tenements Joyntly and Severally
to the use of the said David Daugh his heirs Executors administrators or assigns to be made and Levied &c

If it happen that the said Owen Daugh doe not Learn his said apprentice during the term of the
Trade of afaul wheelwright and lead write and Cypher as far as the Rule of three Inclusive and doe not at
the Expiration of his said Servitude give him anew Suit of Cloathes Over and above his Common wearing Cloathes
and Likewise find and provide for his said apprentice meat drink washing Lodging and Cloathing sufficient for such
an apprentice to have and wear during the term aforesaid &c
