Court here fully understood It is considered by the Court here that the aforesaid Thelak Doughen pay unto his said Lordship the Right honorable the Lord Proprietary for her fine by the Court here upon her Impored for and by Occasion of the premises aforesaid where of in form aforesaid she is found thirty Shillings Current money of Maryland and that the said Thelak be Taken to Satisfie his said Lordship of her fine aforesaid &c.

Whereupon the said Thelak is Ordered to give Security to Save and Keep Indemnified the Justices of the County of Somerset and their Successors from all troubles burthens Costs and Charges that might arise by means of the birth maintenance and bringing up of the Child aforesaid &c.

Thereupon aforesaid Thomas Todovic of Somerset County planter present herein Court in his proper person undertook for the same Thelak Doughen and acknowledged himself Indebted unto his Lordship the Right Honorable the Lord Proprietary of the province of Maryland in Thirty pounds Current money of said Province of his body goods or Chattels Lands or tenements to be made and Levied to the use of the Inhabitants of the County of Somerset for the Time being If it happen that he the said Thomas Todovic his heirs Executors or Administrators or any or either of them doe not from time to time and at all times hereafter acquit discharge and Save harmless as well the Justices of Somerset County Court for the time being as also the Inhabitants of said County of and from all Costs Charges and Burthens what soever for or by Reason of the birth maintenance nourishing and bringing up of the aforesaid Child and of and from all other suit Charges Troubles or demands what soever for troubleing or concerning of the same &c. Likewise the said Thelak Doughen is Ordered to give Security for the payment of all fee or fees due by means of the Information aforesaid to any person or person what soever...

Whereupon the aforesaid Thomas Todovic present here in Court undertook for the said Thelak Doughen to pay all fee or fees due to any person or person on the Information aforesaid In case the said Thelak Doughen doth not pay the same &c.

One thousand seven hundred and forty Two discharged from lewgo. } at about then held at dividing Creek before his Lordships Justices came the aforesaid Edward Bennett in his proper person according to aforesaid Recognizance by him and his Security in this part before acknowledged and prays that his appearance may be Recorded and he and his Security discharged from the Recognizance aforesaid &c. Thereupon the said Edward Bennett's appearance is Recorded and he and his Security accordingly discharged from the Recognizance aforesaid &c.

Whereupon the said Edward Bennett is Ordered to give Security for the payment of all fee or fees due to any person or persons on the Recognizance aforesaid &c.

Thereupon aforesaid Joshua Mitchell present herein Court in his proper person undertook for the said Edward Bennett to pay all fee or fees due to any person or persons on the Recognizance aforesaid In case the said Edward Bennett doth not pay the same &c.
