Whereupon the Court being called and sat as above do proceed to the Execution of their Commission in form following - Thereupon Proclamation being made the Sheriff of Somerset County to wit John Handy Gentleman makes return of a panel of Grand Jurors as follows vizt Alexander Laikie Joshua Caldwell Isaac Williams Phillip Wingate James Stephen Bredall Absalom Hobbs George Sayfield Jonathan Surgis Cannon Winwright Thomas Gibbons John Johnson Thomas Hearn Joseph Gray John Kirk William Jones James Anderson William Langsdall Charles Davis and James Neira. And Thereupon Proclamation being made in Common form &c. the Jurors aforesaid so as aforesaid Impanelled being severally called Over by their Names doe appear as above and were sworn to Enquire and Charged and sent Out to Consider &c.

Soon after the grand Jurors aforesaid being Impanelled Sworn and Charged as aforesaid Return here into Court and being severally called Over appear and present to the Court here the severall Bills of Indictment vizt against Mary Housley, Rose Roach, John Coffin and Benjamin Grumble thereupon the Grand Jurors aforesaid are discharged and Ordered that they be allowed five hundred pounds of tobacco for their publick service this Court to be allowed of in the County Charge, and against the aforesaid Mary Housley Rose Roach and John Coffin so as aforesaid Indicted It is Ordered that said Jurors Returnable here at Next Court &c.

Ordered by the Court here that Robert Jenkins Henry Gents his Lordships attorney, Order out, all such Subpoenas as he should think necessary, to testify to the Grand Jury, at this Court, on behalf of his Lordships, against any person or persons what soever &c.
